- I. Call to Order The meeting was called to order at 11:00 AM.
- II. Approval of the Minutes of the January 23, 2018 Board of Directors Meeting A motion was made by Ms. Garino, seconded by Mr. Long, and carried to approve the draft minutes of the January 23, 2018 Board of Directors Meeting as submitted.

III. President's Report

IV. Committee Reports

- **A. Deed Adherence**: Ms. Brown told the Board that the inspection of February 22, 2018 resulted in 12 First Notices, 1 Invitation to Hearing (for March 27th), and 3 On-Going Fines.

• Stratford Management is in receipt of notification from Pima County Regional Flood Control District that upon inspection, the mature mesquite tree located north of 305 N Vista Del Rio, reported by Stratford Management, has been scheduled for removal. Upon the inspection of the community on February 22nd it was noted that the tree has been removed.

VI. Treasurer's Report

As of January 31, 2018, there was \$41,316.60 in the Operating Account; \$651.97 in the Median Planting Fund and \$9,847.90 in the Cash Reserve Account. There is a total of \$21,983.28 in Certificates of Deposit. Total expenses for the month were \$1,130.84 over budget with legal expenses, postage and printing being over budget.
